

**“2026 Padres VIP Experience” Sweepstakes
OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE THE STATE OF CALIFORNIA AND WHERE PROHIBITED OR RESTRICTED BY LAW. DATES OF SWEEPSTAKES: The “2026 Padres VIP Experience” Sweepstakes (the “Sweepstakes”) begins June 11th, 2026 and ends on September 9, 2026 (the “Sweepstakes Period”), subject to event dates and times at Petco Park (the “Stadium”), located at 100 Park Boulevard San Diego, CA 92101.

ELIGIBILITY: The Sweepstakes is open only to permanent legal residents of California who reside within a seventy-five (75) mile radius of the Stadium and are at least eighteen (18) years of age or older at time of entry (the “Entrant”). Officers, directors, managers and employees of the the Western Area Lexus Dealer Advertising Association, Inc. (the “Sponsor”), Saatchi & Saatchi North America, LLC., the San Diego Padres (“Padres”), and each of their respective parent companies, subsidiaries, affiliates, and related companies, dealers, advertising and promotion agencies, consultants and agents, as well as their immediate family (spouse, parents, siblings and children) and household members of each such person, and any others engaged in the development, production, execution or distribution of this Sweepstakes, including National Sweepstakes Company, LLC (“Independent Administrator”) are not eligible to participate. Sweepstakes is subject to all federal, state, and local laws and regulations. Sweepstakes is void outside the state of California and wherever else restricted or prohibited by law. Entrants who have previously won a contest, sweepstakes, or promotion of any kind sponsored or otherwise associated with Sponsor, Lexus, a division of Toyota Motor Sales, Inc., or Toyota Motor Sales USA, Inc., within thirty (30) calendar days immediately preceding the start of this Sweepstakes are ineligible to participate or win a Prize.

HOW TO ENTER: Locate the Lexus vehicle display outside the Lexus Club onsite during event dates and times (outlined below) and scan the QR Code found on the advertising materials using a web-enabled wireless device equipped with a QR code reader app (free to download). Then, register for the Sweepstakes by completing the official entry form in its entirety including your first name, last name, email address, zip, to receive one (1) entry into the Sweepstakes Period. Message and data rates may apply. Check your mobile plan for rates/details. The Lexus vehicle display will be onsite during all event dates and times at the Stadium during the Sweepstakes Period.

Limit of one (1) entry per person for the entire Sweepstakes. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant’s entry and that Entrant may be disqualified from the Sweepstakes. In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed submitted by the person in whose name and email address were submitted via the Entry Form (“Authorized Account Holder”). Entrants may be required to provide proof of being the Authorized Account Holder. If the Sponsor cannot determine the identity of the person based upon the information submitted via the Entry Form, the respective Entrant will be disqualified. No mechanically or programmatically reproduced entries are permitted. Sponsor will not verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged entries. By entering, each Entrant; (a) represents that he/she/they is at least eighteen (18) years of age and otherwise eligible to participate in the Sweepstakes; and (b) fully and unconditionally agrees to and accept these Official Rules and the decisions of Sponsor, which are final and legally binding in all respects. Any person who tampers with the entry process in any way will be disqualified.

WINNER SELECTION / NOTIFICATION: On or about September 10, 2026 one (1) prize winner (the “Prize Winner”) will be selected at random from among all eligible entries received during the Sweepstakes Period. Odds of winning the prize is dependent upon the total number of eligible entries received during the Sweepstakes Period. The random drawing will be conducted by a Sponsor representative whose decisions are based upon their sole discretion and interpretation of these Official Rules and are final and binding in all respects.

Potential Prize Winner will be notified by a Sponsor representative via email or phone immediately following the drawing. Sponsor representative will make one (1) attempt to reach the potential Prize Winner (“Notification”). In the event that the potential Prize Winner does not respond to any such Notification within two (2) days of the time of issuance or declines the Prize for any reason, or if it is determined by the Sponsor in their sole discretion that the potential Prize Winner is not eligible in accordance with these Official Rules, the potential Prize Winner will be disqualified and an alternate Prize Winner may be selected from among the remaining non-winning eligible entries received during the Sweepstakes Period, time permitting. Once verified via the Notification, the potential Prize Winner will be required to complete and return “Required

Documents” as further described in the “PRIZE CLAIMS” section below. Prize will be awarded to the Prize Winner upon receipt and confirmation of the “Required Documents”.

PRIZES: Prize Winner selected will receive a prize consisting of: i) four (4) suite tickets to the September 25, 2026 home game, ii) one (1) Griffin Colapinto and one Caroline Marks signed surfboards, (iii) A meet and greet with Griffin Colapinto and Caroline Marks.

The Prize Winner will be contacted by a Sponsor Representative regarding their prize and prize will be delivered via mail prior to the date of the game. Prize Winner must be available to attend the Padres home game associated with the prize, or Prize Winner will be disqualified and an alternate Prize Winner will be selected, time permitting, even if the disqualified potential Prize Winner’s name may have been publicly announced. **Travel expenses are not included in the prize. Prize Winner is solely responsible for all federal, state, and local taxes and all other expenses not specifically mentioned herein, including transportation, parking, accommodations, meals, and beverages, incidental expenses and gratuities.** No substitution or cash redemption of prize is permitted. No responsibility is assumed by the Sponsor for any cancellation or rescheduling of any prize related event in whole or in part. In the event of cancellation or rescheduling no alternate or substitute prize for such cancellation or rescheduling will be awarded. Prize is not transferable and may not be resold. Sponsor reserves the right to substitute a prize of equal or greater value if prize becomes unavailable due to reasons beyond the control of the Sponsor.

Padres game tickets and admission to the Stadium are subject to all security, fan conduct, safety, and health requirements and policies put in place by the Padres and its affiliates and subsidiaries, the MLB and its affiliates and subsidiaries, and Stadium, including requirements relating to face masks and enhanced health screenings (which may include a requirement that ticket holders be tested for COVID-19 prior to or during any game or provide proof of full vaccination against COVID-19, as defined by the United States Centers for Disease Control and Prevention, prior to attending any game) as they may be updated from time to time. Prize Winner and any guests must also comply with all applicable ticket terms and conditions and all applicable laws, policies, orders, ordinances, protocols, and guidelines issued by federal, state, and local authorities respecting COVID-19 and other communicable diseases, and attendance at Stadium games is conditioned on such compliance.

No more than the one (1) prize as set forth in these Official Rules will be awarded. The difference in value of the prize as stated herein and value at time of notification, if any, will not be awarded.

Each Prize Winner consents (and agrees to sign any additional documents required by Sponsor, Lexus, a division of Toyota Motor Sales, Inc., or Toyota Motor Sales USA, Inc., to formalize, effect or perfect such consent, except where prohibited by law) for Sponsor, Lexus, a division of Toyota Motor Sales, Inc., or Toyota Motor Sales USA, Inc., and those acting under

GENERAL CONDITIONS: If the performance of Sponsor or Padres of any obligation under these Official Rules or the Sweepstakes is delayed or prevented in whole or in part by acts of God, fire, floods, storm, explosion, tsunami, accidents, epidemics, pandemics (including without limitation the COVID-19 Pandemic), war, terrorism, civil disorder, strikes or other labor difficulties, or by any law, rule, regulation, order, or other action adopted or taken by any federal, state, or local governmental authority, or by any other cause not reasonably within Sponsor's and/or Padres control Sponsor shall have the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes and conduct the Sweepstakes in a manner which in its sole discretion is fair, appropriate and consistent with these Official Rules. Notice of such action by Sponsor will be posted at the Lexus display. In such event, Sponsor reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment or not at all. Sponsor reserves the right in their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Sponsor reserves the right to disqualify or reject any incomplete, inaccurate, or false entry. **ANY ATTEMPT BY ANY PERSON TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAW, AND, SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. SPONSOR'S FAILURE TO ENFORCE ANY TERM OF THESE OFFICIAL RULES SHALL NOT CONSTITUTE A WAIVER OF THESE PROVISIONS.**

The JAMS Rules for selection of an arbitrator shall be followed, except that the arbitrator shall be experienced and licensed to practice law in California. The remedy for any claim shall be limited to actual damages, and in no event shall any party be entitled to recover punitive, exemplary, consequential, or incidental damages or have damages multiplied or otherwise increased, including attorneys' fees or other such related costs of bringing a claim, or to rescind this agreement or seek injunctive or any other equitable relief. Entrants agree that the rights and obligations of any entrant and/or Released Parties and/or any other party shall be resolved individually, without resort to any form of class action. Any demand for arbitration must be filed within one (1) year from the end of the Sweepstakes Period or the event(s) giving rise to the cause(s) of action, whichever occurs first, or the cause of action shall be forever barred whether or not entrant had actual knowledge of the facts giving rise to the demand for arbitration.
